Long Preston Parish Council

Minutes of business conducted by Long Preston Parish Council under authority delegated to the Parish Clerk/Responsible Financial Officer, in consultation with Councillors to be noted as approved by Parish Councillors on 2nd April 2020 Period 1: 5th March to 2nd April 2020

1.1 Cancellation of meetings

- a The Council noted that the clerk/RFO has been authorised to take the decision to cancel the Annual Parish Meeting and the ordinary Parish Council meeting, both scheduled for 2nd April 2020.
- b The Council noted that the clerk/RFO has been authorised to take the decision to cancel all public meetings until further notice and whilst the Government is bringing in legislation to remove the requirement for Parish Meetings to take place in person.
- 1.2 The Council noted that the clerk/RFO is empowered to do anything expedient and necessary to ensure the continuous business of the council, and to deal with mandatory undertakings in order to prevent the authority from incurring liability during the period that the delegation is applicable under the Local Government Act 1972, Section 101.

1.3 The Minutes of the Parish Council meeting held on 5th March 2020 are confirmed.

1.4 Planning

- a <u>To note planning applications received and actions taken</u>
- 1. YDNPA: C/52/644L and 644M/LB full planning permission and listed building consent for alterations to access track arrangements around Manor House and Barn and for installation of glazed screen behind retained cart doors to ground floor cart entrance of barn, Manor House, The Riddings. The Council noted that it had no comments to make.

b <u>To note planning decisions received</u>

- c <u>To note other planning matters</u> The Council noted the cancellation of the meeting with CDC regarding planning issues as well as that it noted that the Parish Council had no planning issues to provide to CDC.

1.5 To note actions regarding parish maintenance matters

- a. <u>street lighting matters:</u> No reports received or actions taken.
- b. <u>trees matters:</u>

The Council noted the removal of the Sycamore tree on Maypole Green as well as it noted the best location for the replacement tree. Also, the Council noted that the stump is made hollow for a shrub to be planted inside.

- <u>Playing Fields matters:</u>
 The Council noted that the entrance to the Playing Fields has been taped off as per Government instructions and that signs have been put up.
- d. <u>Western Green clearing and YDNPA Trees Preservation Officer site visit:</u> The Council noted that this project has been cancelled until further notice as a result of the Covid-19 pandemic
- e. <u>extending the parish trees planting project</u> The Council noted that this project has been cancelled until further notice as a result of the Covid-19 pandemic
- f. <u>village summer planting volunteer project:</u> No reports received or actions taken.
- g. <u>lengthsman services matters:</u> No reports received or actions taken.
- h. grass cutter services matters:

The Council noted the reply from Zurich Municipal regarding personal insurance for the contractor that if the contractor was injured due to the Council's negligence then this would be covered under the Council's public liability section of the policy. However, if the contractor just fell over and broke his arm this would not be the Council's fault and it is not something the insurers would cover and the contractor should have his own insurance in place.

1.6 To note reports and updates on parish matters other than maintenance

a. <u>letter to owners of Back Green Cottages:</u> No reports received or actions taken.

b. Back Green damage:

The Council noted that NGN ceased all non-essential work and will only be dealing with gas escapes and emergency repairs. As a result, at this present time NGN will not be able to carry out the reinstatement on Back Green.

- c. <u>CDC's initiative 'Happy to Chat Bench':</u> No reports received or actions taken.
- d. VE Day 75 commemoration proposals:

The Council noted that this event has been cancelled until further notice as a result of the Covid-19 pandemic.

e. <u>contribute to Settle Town Council for allotment improvement:</u>

The Council noted that Settle Town Council plan to improve both sets of allotments with water facilities in Cammock Lane Allotments and improved drainage in Dog Meadow Allotments. The Council also noted that Settle Town Council have agreed that the parishes where non Settle plot holders live should contribute £25 per plot holder per year towards running and improvement costs of Settle allotments and as there are 2 Long Preston plot holders for 2020-21 this is £50. The Council noted that Councillors were invited to give their opinion on this item by email or telephone to the officer.

f. Parish Magazine delivery

The Council noted that delivery of the Parish Magazine is suspended until further notice as it is deemed unsafe to do so during the corona virus pandemic. The Craven Herald will publish an article about the support to the community on offer in the parish. The magazine will now be left at the side of the Post Office by the books for parishioners to collect. The Committee has uploaded the parish magazine for December /January, February, March and April 2020 on the village website and the community support group article can be found on page 6 of the April issue.
